

**Solutions Sober Living Community Rules & Regulations Agreement:**

Solutions requires a 4-mo. minimum commitment, rent begins at 180.00 per week. A security deposit of 240.00 is required upon admission (unless special arrangements are made in advance) and is refunded upon completion of our program.

- 1. If you are in possession of or under the influence of any mood or mind-altering substances you will be immediately discharged from Solutions and will forfeit any advanced rent or security paid to Solutions. Random drug testing is done on site at discretion of Director.
- 2. All men will be required to seek and obtain full time employment. All men that are unemployed will be required to leave the property Monday thru Friday from 8:30 am until 4:30 pm to conduct an active employment search until employment is secured and will report to Joe to review the job search unless special arrangements have been made in advance.
- 3. Abusive behavior will not be tolerated; this would include displays of hostility, verbal threats, physical threats, personal insults or disrespectful comments made towards residents or staff. Any attitudes that are a detriment to the community will not be tolerated.
- 4. Mandatory Meetings: Monday Night Study Group is held off property 7-8pm, all men are required to arrive by 6:30pm. Wednesday the Solutions 12 & 12 Study is held on property @ 7 pm. All residents that are in their first 60 days of residency will be required to attend 4 additional meetings per week for a total of 6 per week.
- 5. All residents will be required to retain an AA sponsor and become engaged in the 12 Steps within the first 2 weeks of admission.
- 6. No Smoking in any building on Solutions property, smokers will use ashtrays provided and are prohibited from discarding cigarette butts on property grounds.
- 7. Curfew is 11pm every night. Overnight passes are considered for resident's current in their rent and security deposit & have been a resident of Solutions for at least 30 days.
- 8. Each resident will be required to keep their personal area neat, clean and organized at all times. Beds are to be made daily when not used, laundry and bed linen is to be washed weekly, dirty laundry will be kept in a hamper or plastic bag. Personal hygiene consisting of at least one shower per day is strictly adhered to.
- 9. All residents will be required to contribute up to 1 hour per week to the maintaining the grounds of the Solutions property on Friday afternoon. NOTE: (if client is working, they will be required to fulfill obligation on Saturday).
- 10. A House chore will be assigned weekly to each resident to be carried out on Tuesdays, Thursdays and Saturday. Chores rotate each week and are posted on Bulletin board.
- 11. No borrowing or lending money to any resident, No taking of anyone's property whether in a refrigerator or personal area. Theft of any kind results in immediate discharge.
- 12. No food or eating allowed in bedrooms, all dishes are to be washed and placed in dish rack. Absolutely no dishes are to be left in sink. Counter tops, microwave and stove will be cleaned after each use.
- 13. A 2 week notice is required prior to leaving Solutions, if a resident does not complete the their minimum commitment or leaves unannounced or is discharged for violating any of the above rules, any advanced rent or security deposit held by Solutions will be forfeited, any personal belongings will need to be picked up within 72 hours.

**14. I agree to the rules and regulations and will abide by them, if I am discharged and asked to leave Solutions for violation of any of the above rules and I refuse a Broward County Sheriff's Department will be called.**
